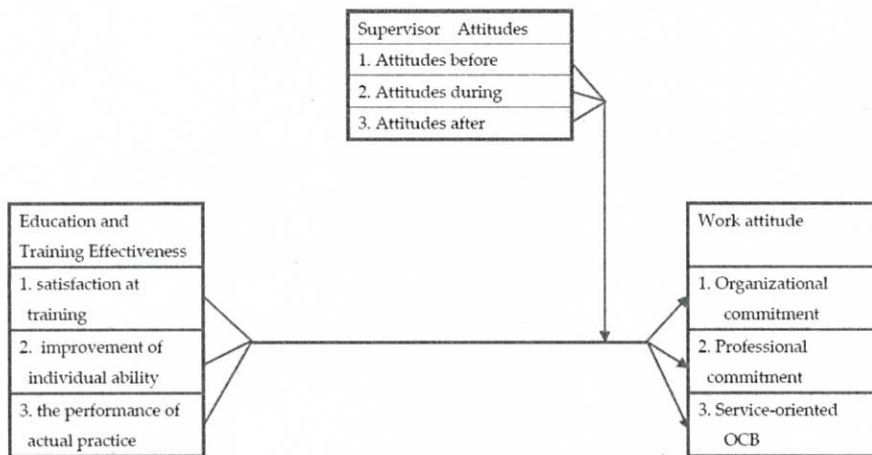


Figure 1. Research model.
