Graduation

- Complete the NSYSU **graduation thesis and oral defense** under the supervision of an NSYSU professor, following NSYSU regulations.

- **How much should I pay for tuition ? Any Scholarship ?**

Can be waived if you completed one year study in IBMBA or GHRM MBA

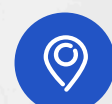
