

# **National Sun Yat-Sen University College of Management**

## **Regulations for the Appointment of Associate Dean**

Approved by the 1<sup>st</sup> College Affairs Council on December 17, 1997, Academic Year 86

Amended and Approved by the 1<sup>st</sup> Extraordinary Meeting of the College Affairs Council on October 24, 2006, Academic Year 95

Amended and Approved by the 3<sup>rd</sup> College Affairs Committee on March 12, 2008, Academic Year 96

Article 1. According to the 'National Sun Yat-sen University Regulations for the Election, Renewal and Dismissal of Academic Supervisors of All Ranks', two associate deans shall be appointed to assist the Dean in managing College affairs and in promoting the development of the College. Their responsibilities shall be as follows:

1. Associate Dean of Academics: To assist the Dean in promoting research, international collaborations, accreditations, as well as other tasks assigned by the Dean.
2. Associate Dean of Teaching: To assist the Dean in promoting college freshman and sophomore general studies, course curriculum, course integrations, as well as other tasks assigned by the Dean.

Article 2. The College Associate Deans are ex-officio members of the Directors' Council, the College Affairs Council and the Curriculum Committee.

Article 3. The period of appointment for the Associate Dean shall be effective upon approval by the College Affairs Council and until the end of the Dean's appointment.

Article 4. The Associate Dean shall be a full-professor, appointed by the Dean, approved by the College Affairs Council, and signature approved by the University President.

Article 5. These regulations, as well as its amendments, shall be effective upon approval by the College Affairs Council.

一、本院依「國立中山大學各級學術主管遴選續聘及解聘實施要點」設置副院長二人，襄助院長處理院務，並推動院務發展。其職責如下：

（一）學術副院長：協助院長推動院學術研究、國際交流、評鑑，以及其他經院長指派之任務。

（二）教學副院長：協助院長推動院大一大二不分系學程、課程規劃、課程整合，以及其他經院長指派之任務。

二、本院副院長為院主管會議、院務會議及院課程委員會之當然委員。

三、副院長之任期自院務會議通過日起至院長任期屆滿為止。

四、副院長由院長提名正教授，經院務會議同意，簽請校長同意後聘任之。

五、本辦法經院務會議通過後實施，修正時亦同。
