

National Sun Yat-sen University College of Management
**Regulation Governing the Awarding ‘Honorary Chair Professorships and
Distinguished Chair Professorships’**

Approved by the College Affairs Council on November 14, 2001, Academic Year 90
Amended and Approved by the 2nd College Affairs Council on January 17, 2002, Academic Year 90

- Article 1. This regulation was put in place to extend courtesy to experts who show particular expertise or contributions and show promise in promoting the reputation and development of the College.
- Article 2. The College holds two types of chair professorships: Honorary Chair Professors and Distinguished Chair Professors; both are unpaid positions.
- Article 3. Honorary Chair Professors must be recommended by the Faculty Evaluation Committee at the Department-level. Upon approval by the ‘Faculty Evaluation Committee at College-level’, Honorary Chair Professors are awarded for a maximum of one year. Honorary Chair Professors may offer a course taught together with a faculty of the College. In addition, during the faculty’s appointment, he/she may offer one open seminar to all faculty and students of the College.
- Article 4. Distinguished Chair Professors must be recommended by the ‘Faculty Evaluation Committee at the Department-level’ and reviewed by the ‘Faculty Evaluation Committee at the College-level’ to be awarded. The appointment period is dependent upon circumstances; however, the appointment period should not exceed a maximum of one year. During the faculty’s appointment, he/she must offer at least one open seminar to all faculty and students of the College.
- Article 5. This regulation, as well as its amendments, shall be effective upon approval by the College Affairs Council.

1. 為禮遇具有特殊專業造詣或成就，且有助提升本院聲望及發展之專業領域人士，特訂定本要點。
2. 本院講座分為榮譽講座及特約講座兩種，皆為無給職。
3. 榮譽講座須經系所教評會推薦，由院教評會審核通過後，授與榮譽講座，聘期視需要而定，以不超過一年為原則。榮譽講座得與本院教師合開課程，並於聘任期間對全院師生舉辦公開演講一場。
4. 特約講座須經系所教評會推薦，送院教評會備查後，授與特約講座，聘期視需要而定，以不超過一年為原則。特約講座須於聘任期間對全院師生至少舉辦公開演講一場。
5. 本要點經院務會議通過後實施，修正時亦同。
